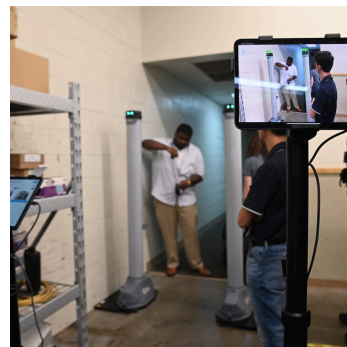
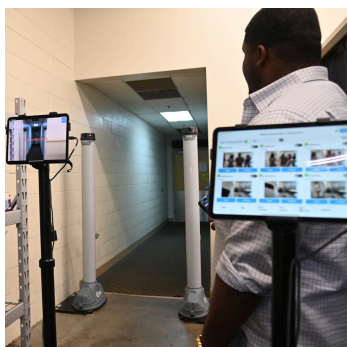

## IMPLEMENTATION

In August 2025, our team was on-site at Idaho Falls Regional Airport to complete a full installation and training program in just three days. The system was set up and operational with minimal disruption to airport operations, ensuring immediate compliance with TSA's employee screening mandate. During our time on-site, we worked directly with airport security staff to provide hands-on training, fine-tune system settings, and integrate with existing access procedures. By the end of the three-day deployment, the airport was fully equipped, staff were confident in system operation, and the airport had a proven, TSA-compliant employee screening solution in place.



## RESULTS SNAPSHOT

The deployment of Athena's system led to notable safety improvements:

**Streamlined Employee Screening** – The system optimizes the employee entry process by combining rapid weapons detection with an efficient screening workflow. Employees move through security quickly, reducing wait times and congestion, while ensuring consistent compliance with TSA and airport protocols. The intuitive interface allows security personnel to manage screening with ease, improving both speed and operational reliability.
